<p>Violation #10. Handwashing sinks, accessible & supplies Observe handwashing sink in the bathroom with no paper towel. Replace paper towel. CODE REFERENCE: 64E-11.003(5)(d). Handwashing sinks are properly equipped with hand soap, individual disposable towels or hand drying device, and signage; and conveniently located.</p>
<p>Violation #13. Food in good condition, safe, & unadulterated Observe 5 bags of expired breads (3/25/19). Return expired breads to company for credit. COS CODE REFERENCE: 64E-11.003(1). The food packaging shall not be compromised nor the true appearance, color, or quality of a food be intentionally altered.</p>
<p>Violation #23. Date marking and disposition Observe sugar in plastic container in the refrigerator not label and dated. Label and date food items not in its original packaging. COS CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are RTE and held refrigerated for more than 24 hours, shall be properly date marked unless otherwise exempted.</p>
<p>Violation #36. Thermometers provided & accurate Observe milk cooler and refrigerator with no thermometer. Replace thermometer. CODE REFERENCE: 64E-11.003(4). Thermometers must be calibrated to ensure accuracy in accordance with Rule requirements. Food thermometers scaled in Celsius (C) shall be accurate to plus or minus 1°C or in Fahrenheit (F), accurate to plus or minus 2°F. Food thermometers should be accessible for use by employees and have a probe size appropriate to the food item.</p>
<p>Violation #47. Food & non-food contact surfaces Observe milk cooler leaking water, towel being use to soak up water, plastic tube on the floor. Repair/replace milk coder. CODE REFERENCE: 64E-11.003(4). Equipment and utensils must be properly designed, constructed, and in good repair.</p>
